Established and currently lead the development of a regular radio series that provides current research-based information about family life in a listener-friendly format. Over 1100 scripts have been produced and aired daily to a local, regional and national listening audience. The website attracts thousands of users world-wide. Personal role includes supervising all script production by the Writer and Host, writing hundreds of scripts on current research and interpreting results for family use, involving dozens of students in script writing, and assisting with marketing.

Develop educational programs for use by families and professionals in their communities, with an emphasis on the topics of family stress, coping and resilience; family communication; work and family; and elder caregiving. Develop educational materials including a variety of print and audiovisual materials, train professionals to deliver programs, and support the evaluation of program effectiveness.
